**I agree with the itinerary and conditions of my purchase and authorize payment as outlined. Clients of Darby's Destinations are solely responsible for reviewing and understanding the quote and confirmed reservations along with the terms and conditions of all Suppliers (cruise lines, airlines, hotels, tour operators, car rental companies, and other service providers) and Travel Insurance providers.**

**Deposits are nonrefundable unless otherwise noted by Supplier. Air tickets are nonrefundable, and any changes must be made before your flights are ticketed and date on your ticket, or it has no value, and any changes will incur a change fee from the airlines.**
